

Commercial Circular No.18(G)/2025

Sub: Commercial notification of 61 BFNW wagons (17th of 22 rakes) and 01 Brake Van procured by M/s Jindal Steel & Power Limited under Liberalized Special Freight Train Operator (LSFTO) Scheme.

- 1) Railway Board vide letter dtd.11.10.2022 under reference-(i), have granted permission to M/s Jindal Steel & Power Limited for procurement of 22 (Twenty two) rakes of BFNW wagons (including 4% spare wagons) and twenty two Brake Vans to operate under the LSFTO Scheme.
- 2) On the authority of Railway Board's letter dtd.11.10.2022 under reference-(i), this Railway has executed LSFTO Agreement No.PCCM/ECOR/LSFTO/JSPL-JSPK/BFNW/2022/1 dtd.23.03.2023 with M/s Jindal Steel & Power Limited for movement of commodity "Hot Rolled Coils / Cold Rolled Coils" in 22 rakes of BFNW wagons (including 4% spare wagons) along with 22 Brake Vans under LSFTO Scheme.
- 3) Out of the aforementioned twenty two BFNW rakes approved by Railway Board, 1st rake (61 wagons), 2nd rake (61 wagons), 3rd rake (61 wagons), 4th rake (61 wagons), 5th rake (61 wagons), 6th rake (61 wagons), 7th rake (61 wagons), 8th rake (61 wagons), 9th rake (61 wagons), 10th rake (61 wagons), 11th rake (61 wagons), 12th rake (61 wagons), 13th rake (61 wagons), 14th rake (61 wagons), 15th rake (61 wagons), 16th rake (61 wagons) and 16 Brake Vans of M/s Jindal Steel & Power Limited under LSFTO have been notified vide this office commercial circulars under reference-(ii). Now, in this series, the customer has inducted their 17th rake (61 BFNW wagons) and 01 Brake Van under LSFTO. The list of subject 61 BFNW wagons and 01 Brake Van procured by the customer is enclosed as Annexure-1.

- 6) Permitted Commodities to be carried in the subject wagons are Hot Rolled Coils / Cold Rolled Coils & Steel Commodity.
- 7) Freight rebate to be granted on the subject BFNV rake as per Clause No. 11.2 & 11.3 and Annexure of LSFTO policy vide Railway Board's FREIGHT MARKETING MASTER CIRCULAR/LSFTO/2020/0 dtd.16.03.2020 {Circulated vide this office Commercial Circular No.55(G)/2020 dtd.17.03.2020}.
- 8) The freight concession will be granted only on the wagons specified at Annexure – 1. The date of commencement of the concession will be from the date of this notification i.e. **08.01.2025** and the period of concession shall remain valid for 20 years i.e. **upto 07.01.2045**.
- 9) Various details of this traffic like number of trips, total freight, rebate, lead in empty and loaded direction etc. should be maintained at the respective loading and unloading points and furnished to divisional head quarters duly signed by CGS or SM of the respective stations. The said monthly statement should be furnished by Sr.DCM of respective divisions to PCCM/ECoR/BBS for appraisal.
- 10) The Standard rake size, PCC, Designed tare weight, etc. of BFNV wagons will be as per notification issued by Railway Board from time to time.
- 11) The SFTO will be the Consignor for the consignment for which Railway Receipts will be issued at loading points. The Consignee shall be as per the details provided in the Forwarding Note by SFTO. However, SFTO shall be responsible for the payment of all dues and damages to Railways, including those arising on part of consignee.
- 12) Sr.DCMs of loading/unloading points are advised to ensure the availability of the copy of the agreement and this circular at loading/unloading points. The sectional CMI may guide supervisors / staff concerned at the loading/unloading points regarding correct charging of the said BFNV rake as per the provision of this circular and LSFTO Agreement dated 23.03.2023 executed between the customer and ECoR.
- 13) CGS / In-charge of loading/unloading points are advised to ensure correct charging as per the provision of this circular and LSFTO Agreement dtd.23.03.2023 executed between East Coast Railway & M/s Jindal Steel & Power Limited.
- 14) This BFNV rake of M/s Jindal Steel & Power Limited will be governed by LSFTO policy and amendments/corrigendum/addendum/revision to LSFTO policy issued by Railway Board from time to time.
