**Sub:** Discontinuation of loading of 4 BOXN rakes of M/s MSPL Ltd. under Own Your Wagon Scheme over East Coast Railway.


Railway Board vide letter dated 13.04.2022 under reference (i), had accorded sanction for temporary transfer of four (04) BOXN rakes of M/s MSPL Ltd. from SWR to ECoR initially for a period of 1 year with loading points at GADH, PRNR & NYG and unloading point at DPCB over ECoR which was valid up to 12.04.2023. Railway Board vide letter dated 08.11.2023 had accorded extension of temporary transfer of the above 04 rakes from SWR to ECoR for one more year i.e. up to 20.02.2025 and accordingly Circulars under reference (ii) have been notified.

Now Railway Board vide letter under reference (iii), have disagreed to the proposal of M/s MSPL Ltd. for extension of aforesaid temporary transfer. In this regard, it is hereby instructed to **discontinue the loading of rakes of M/s MSPL Ltd. under Own Your Wagon Scheme w.e.f. 21.02.2025.**

All concerned to note and act accordingly.


