Sub: Incorporation of rationalized RBS route in place of existing via route for six rakes of BFNW wagons of M/s TM International Logistics Limited under LSFTO Scheme – Reg.

- 1) This office vide Commercial Circulars under reference-(ii), had notified four BFNW rakes (out of six BFNW rakes) of M/s TM International Logistics Ltd under Liberalized Special Freight Train Operator (LSFTO) Scheme for various close circuits (loading/unloading points) and commodities as stipulated therein.
- 2) Now, Railway Board vide letter under reference-(iii) dtd.18.12.2024, have approved for incorporation of rationalized RBS route in place of existing via route for all rakes under LSFTO i.e. six BFNW rakes from existing via route vide Railway Board's letters and addendums under reference-(i) to via-route "**As per RBS route including Rationalized Route, if any**".
- 3) In view of the above, the modified circuit with **via-route** will be as under:
