## Commercial Circular No.55(G)/2025

**Sub:** Notification of additional loading/unloading points (O-D pairs) for 22 rakes of BFNW wagons of M/s Jindal Steel & Power Limited under Liberalized Special Freight Train Operator (LSFTO) Scheme.

- 1) Vide Commercial Circulars under reference-(ii), 17 rakes of BFNW wagons (out of 22 BFNW rakes) of M/s Jindal Steel & Power Limited have been notified under Liberalized Special Freight Train Operator (LSFTO) Scheme for various close circuits (loading/unloading points) and commodities as stipulated therein.
- 2) Now, with the approval of Railway Board vide letter under reference-(iii), following pairs of loading-unloading points are hereby included as additional loading/unloading points (O-D pairs) for the subject 22 rakes of BFNW wagons for transportation of Steel Commodity under LSFTO Scheme. Transportation of commodities not covered under LSFTO will be permitted as per the extant provision of LSFTO policy (i.e. with full freight) :
