Sub: Notification of additional O-D pairs (loading/unloading points) for four rakes of BRN 22.9 wagons of M/s Jindal Steel & Power Limited under Liberalized Special Freight Train Operator (LSFTO) Scheme.

- 1) Vide Commercial Circulars under reference-(ii), 04 rakes of BRN 22.9 wagons of M/s Jindal Steel & Power Limited have been notified under Liberalized Special Freight Train Operator (LSFTO) Scheme for various close circuits (loading/unloading points) and commodities as stipulated therein.
- 2) Now, with the approval of Railway Board vide letter under reference-(iii), following pair of loading/unloading points are hereby included as additional O-D pairs for the subject 04 rakes of BRN 22.9 wagons for movement of Iron and Steel product under LSFTO policy. Transportation of commodities not covered under LSFTO will be permitted as per the extant provision of LSFTO policy (i.e. with full freight) :
