**Sub: Traffic of M/s. Vizag Seaport Private Limited's siding under Visakhapatnam Port Authority.**

**Ref: PCCM/ECOR's Commercial Circular Nos. 21(G)/2008 dt.22.02.2008 and No.195(G)/2021 dtd.03.06.2021.**

1. Vide PCCM/ECOR's Commercial Circulars under reference, the siding of M/s. Vizag Seaport Private Limited under Visakhapatnam Port Authority was notified as an independent booking point with Alpha Code - VSPV and Numerical code - 12337720.
2. Consequent upon the electrification of the siding, the siding of M/s. Vizag Seaport Private Limited (**Alpha Code - VSPV and Numerical Code - 12337720**) under Visakhapatnam Port Authority was notified for charging of freight on Through distance basis with chargeable distance as:

**a) SCMN + 10.51 Km (Ten decimal Five One Km)**

**b) DVD + 18.93 Km (Eighteen decimal Nine Three Km)**


3. Now, with the approval of competent authority, the permitted commodities at the VSPV siding is modified as under:

**Inward: All except bagged consignment in Covered stock.**

**Outward: All except bagged consignment in Covered stock.**
