**Sub:- Notification for conducting selection to form a panel of 14 (fourteen) posts of Technician-III (AC) in Elect.(Gen) deptt. in Level-02 against 25% QSQ in Electrical (G) department of KUR division/ECOR.**

Formation of panel for selection to fill up 14 nos. (fourteen) posts of Technician Grade-III (AC) in Level-02 in Electrical (G) department of KUR division against 25% QSQ.

The break-up vacancies are detailed below:-

**No. of vacancies(category wise):**

Options are accordingly, invited from eligible staff who are willing to appear the above selection. The candidates should satisfy the following eligibility criteria as on the date of notification. The above assessment of vacancies included one PwBD vacancy as per RBE No.74/2022.

**(A) Eligibility:**

All the serving Helpers (AC) i.e. Assistant (AC) of Elect(G)/KUR possessing minimum 02(two) years of regular service vide RBE No.20/2019 as on the date of notification i.e. **27.02.2025** and having the following qualifications are eligible to apply:-

- d) Course completed Act Apprentices **OR**
- e) ITI Passed **OR**
- f) Matriculation Passed.

In the case of staff who are appointed as substitutes and subsequently regularized in a post of Gr.D categories are required to fulfill the service conditions of two years counted from the date of regularization. In respect of employees who have reported/joined in this division on Inter Railway/ Inter Divisional Own Request Transfer on bottom seniority, the service rendered in relevant category in the old unit (not exceeding the length of service of immediate senior in KUR divn. as per RBE No.34/2006) will count for the purpose of qualifying service for promotion in the new seniority unit provided:-

- ii) He/she otherwise eligible to be considered for the selection to Gr.C post as per extant rules.
- iii) The category in which he/she was working in the old unit is an eligible category for the selection/post in new unit also (RBE No.99/06 followed by EPS-19/06).

**(B) Mode of selection**

- (1) Selection will be based on the written test to assess the professional ability of the applicants followed by scrutiny of service records and APARs (for the year **21-22,22-23, 23-24**) in respect of the staff who will qualify in the written examination by the selection board. The candidate have to secure a minimum 60% marks in the professional ability (written test) as well as in aggregate to find a place in the panel subject to availability of category wise vacancy. The Panel will be formed based on merit position secured in the selection as per Para-189 of IREM Volume-I,(Chapter-I) & RBE No-17/2014, subject to free from D&A/SPE/Vigilance cases.
- (2) There will be no supplementary examination for the absentees, being a general selection.
- (3) There will be no classification of Outstanding.
- (4) The post of Tech-III being classified as safety category post, there is no relaxation in qualifying marks to the employees belonging to SC & ST categories. They are also required to secure 60% marks in written test as well as in aggregate.

(5) As per existing instruction issued by RBE No.196/2018 & RBE No.97/2019 the mode of written test will be conducted as follows:-

- vii. The written examination is to be conducted on OMR Sheet. The duration of the written examination will be 120 minutes(Two hours/02hrs).
- viii. The question paper will be 100% objective types.
- ix. There will be 110 questions including 10 questions (optional) on Rajbhasha of objective multiple choice types with four answer options in the sequence A,B,C& D. The candidate has to answer a maximum of 100 questions. In case, the candidate answers more than 100 questions, first 100 attempted questions are to be taken for evaluation.
- x. To ensure the authenticity of the answer, cutting, overwriting, erasing or alteration of any type in the answer will not be accepted. Zero mark will be awarded for Answer having correction/overwriting.
- xi. It is being a general selection; there is provision of negative marking for wrong/incorrect answer and 1/3 marks will be deducted in terms of RBE No. 196/2018.
- xii. All objective type questions will carry equal marks.

**(C) Syllabus:-**

Copy of the Syllabus for the selection to the post of Tech-III (AC) against 25% QSQ of Elect.(G) deptt. as approved by PCME/ECOR/BBS and issued by PCPO/ECOR/BBS L/No.-ECOR/Pers/08/Elect/ Syllabus/184, dtd.24.09.2019 in addition to the Vande Bharat Express as added by Sr.DEE(G)/KUR is enclosed for circulation amongst the aspirants. Any discrepancies in the questions will be governed under instructions in RBE No.-59/2022. In this regard, the decision of the question setter will be final.

**(D) Pre-selection Coaching:-**

The pre-selection coaching for the reserved community candidates is to be imparted for 03 to 04 weeks covering the syllabus of the examination for the selection to the safety category post. After pre-selection coaching, a certificate is to be issued by the controlling officer to this effect that, all such candidates have been imparted pre-selection coaching. In case, if any candidate expressed his unwillingness for pre-selection coaching a written declaration to that effect may be obtained from the candidate and forwarded to this office for record as per RBE No.-174/1997.

**(E) Training to the empanelled candidates:-**

The empanelled staff will be imparted training as per RBE No.-87/2022. On completion of the said training they will be subjected to Trade Test and on passing the Trade Test, will be promoted as Technician-III in Level-02.

**(F) Last date & Mode of receipt of application etc.**

The willing staff fulfilling the above conditions should submit their applications in the enclosed proforma to their respective in-charges i.e. SSEs/JEs. Applications received after **27.03.2025** should not be entertained at all and such applicants will not have any claim to appear the selection.
