Sub: Sanction of itemized works under sub umbrella works under PH-51 (Staff Welfare) and PH-64 (Other Specified Works) for WP 2023-24

The progress of sanction of itemized works under sub umbrella works of PH-51 & PH-64 allocated to zonal railways for the WP 2023-24 has been perused (copy enclosed). It is noticed that about 25% amount under PH-51 and 48 % amount under PH-64 is still unutilised for sanction of itemized works in WP 2023-24.

2.0. It may kindly be noted that the unutilised amount of umbrella work sanctioned in WP 2023-24 will lapse after 31/03/2025 and no itemized work will be sanctioned after 31.03.2025. With less than two months remaining in the current financial year, effective monitoring of both physical and financial progress of works at all levels is imperative to avoid surrender of funds.

3.0 In view of the above, all Zonal Railways are advised to sanction itemized works under Plan Heads 51 & 64 of WP 2023-24 by the end of current month. In case of failure of zonal railways to sanction itemized works under these Plan Heads in current month, the available unutilized amount with these zonal railways will be allocated to other zonal railways for sanction of itemized works.
