Sub	Re-engagement of Retired Pharmacist/Chief Pharmacist in Medical Department of HQr controlled post of ECoR.
Ref	Railway Board letter No. E(NG)II/2024/RC-4/9 dated 15.10.2024 (RBE No.: 96/2024)

- In terms of Railway Board's letter under reference, it has been decided for re-engagement of the retired Pharmacist/Chief Pharmacist in the Medical Department of HQr controlled post of ECoR.
- Number of vacancies: 01 (One).**
- Eligibility Condition:**
 - Retired Pharmacist/Chief Pharmacist who retired from Railway Service.
 - Excludes those under SRRS/LARSGESS or with DAR/Vigilance cases.
 - Must have "Good" grading in the last 5 APARs.
 - Maximum age: 65 years.
- Remuneration:** The remuneration and allowances for re-engaged retired staff will be as per OM No. F.No.3-25/2020-E.IIIA dated 09.12.2020 issued by the Department of Expenditure, Ministry of Finance, Government of India which are as under:
 - A fixed monthly remuneration will be calculated by deducting the basic pension from the pay drawn at the time of retirement. This amount will remain unchanged during the contract period.
 - No increment, Dearness Allowance (DA), or House Rent Allowance (HRA) will be allowed during the contract period.
 - A fixed Transport Allowance for commuting between residence and the workplace will be allowed, not exceeding the rate applicable at the time of retirement. This amount will remain unchanged during the contract period. However, TA/DA for official tours will be allowed as per entitlement at retirement.
 - Paid leave will be granted at the rate of 1.5 days per completed month of service. Accumulation of leave beyond a calendar year is not allowed.
- Mode of Selection:** Suitability/competency of the staff should be adjudged by a committee at an appropriate level before such re-engagement duly taking into account safety and other operational requirements.
- Duration of Re-engagement Scheme:**
 - The scheme will remain in effect for an initial period of 2 years from the date of issue of instructions or until further orders, whichever is earlier.
 - The engagement period for an individual retired staff will be 1 year or until further orders, whichever is earlier.
 - Based on satisfactory performance, the engagement may be extended for an additional year or until the retiree attains 65 years of age, whichever is earlier.
 - Re-engaged staff should be discharged immediately on joining of selected candidates from RRBs.

7. **Other Terms and Conditions:** All other terms and conditions for re-engagement will be governed by Railway Board letter No. E(NG)II/2024/RC-4/9 dated 15.10.2024 (RBE No.: 96/2024) and any other orders issued by the Railway from time to time.

 - a. Application in prescribed format.
 - b. Service Certificate.
 - c. Pensioner Identity Card.
 - d. Pension Payment Order.
 - e. Three passport size photographs.
9. **HOW TO APPLY:** Eligible & interested Retired employees are advised to send their applications in prescribed format along with self attested Photostats copies of the relevant documents addressed to **Principal Chief Personnel Officer, East Coast Railway, Rail Sadan, 2nd Floor, South Block, C.S.Pur, Bhubaneswar-751017** superscribing on the top of the envelope "Application form for re-engagement of retired employee for Pharmacist." **on or before 21-03-2025** and the date of viva-voce test will be intimated over telephone or letter for attending the viva-voce test accordingly.
10. **Retired employees are hereby requested to read the terms and conditions in detail as outlined above and in RBE No.: 96/2024. Submission of an application will be treated as acceptance of all the terms and conditions specified in this notification.**
11. No TA/DA/Accommodation will be provided to the retired railway employees for attending the viva-voce Test.
