

**Sub:- Selection for filling up of One Ex-cadre Tenure Post of Vigilance Inspector /Personnel in Pay Matrix Level-7 (Scale Rs. 9300-34800 in grade pay Rs. 4600/- 6<sup>th</sup> PC) in Vigilance Organization.**

- 1) Applications are invited to fill up 01 (One) vacancy of ex-cadre post of Vigilance Inspector / Personnel in Pay Matrix Level- 7 (Scale of Rs. 9300-34800/- in Grade Pay Rs. 4600/- 6<sup>th</sup> CPC) in vigilance organization North Western Railway Jaipur. The tenure of the post will normally be for three (03) years, which may be curtailed / extended as per extant rules.
- 2) **Eligibility:-**
  - (i) Staff of the Personnel Department of Indian Railway Working in Pay Matrix Level-6 & 7 (Scale of Rs. 9300-34800/- in Grade Pay Rs. 4200/- & 4600/- 6<sup>th</sup> CPC) on regular basis on the date of notification. The staff who have got financial up-gradation from Level-7 to Level-8 under Group 'C' cadre is also eligible for the post to apply.
  - (ii) The staff should have completed at least five (05) years service in Railway as on date of notification.
  - (iii) Staff who have already completed their tenure in the vigilance organization of Zonal Railways / Production Units/ Railway Board earlier as Vigilance Inspector / Investigating Inspector (Vigilance) are not eligible to apply. However, if they have completed required cooling off period (minimum 02 years) as on 31.12.2024, thereafter they are also eligible to apply.
  - (iv) Integrity of staff should be beyond doubt. Staff should have clear Vigilance history and should not have undergone any penalty in Vigilance/SPE case. Also the staff should not have undergone / undergoing any penalty under DAR in the last 03 years.
  - (v) Working knowledge of computer is essential.

3) Wide publicity of the above vacancy notice may kindly be given and this should also be displayed prominently on notice boards for information of the staff: Controlling officers are requested to forward the applications of those employees who have not undergone any penalty in Vigilance/ SPE case during their service period and employees who have not undergone any penalty under DAR in the last 03 years, should only be forwarded. It must be ensured before forwarding the application, that the applicant is fulfilling the eligibility criteria.

4) Procedure for submission of application:-


- (i) Application should be made in the prescribed pro-forma. Applications should be forwarded through proper channel. Application not received 'through proper channel' will be summarily rejected. No direct application will be entertained, the applications of candidate duly forwarded by their controlling officers should be sent to this office by the concerned Personnel Branch of the Unit/Division/HQ in a bunch.
- (ii) Application, as per enclosed proforma must be filled and signed by the candidate, giving the correct information to the best of his / her knowledge. No alterations / corrections on the application will be entertained. Applicants must note that if any information furnished by him / her is found to be false at any stage, the application / candidature will liable to be rejected. Submission of false or misleading information by applicant may be lead to D&AR action against him / her.
- (iii) Applications/options should reach the office of General Manager (Vigilance), North Western Railway, Jaipur latest by 13.03.2025 duly forwarded through proper channel along with attested photograph (Units should forward applications to concern personnel branch by 03.03.2025 and the concerned personnel branch should send the application collectively to this office by 13.03.2025). Eligible candidate should be ready to be called for selection within due course.

5) Service sheets & APARs: To avoid delay attested true copies of the updated service sheets and certified copies of the APARs for the last three years (i.e. period ending 31.03.2022, 31.03.2023 & 31.03.2024) in respect of all the applicants should be sent collectively to "General Manager (Vigilance), Vigilance Department, North Western Railway/HQ, Near Jawahar Circle, Jaipur PIN-302017" *latest by 13.03.2025*. Applications received after due date may not be considered. Application of the eligible candidates duly filled up in the enclosed proforma and completed in all respect may be forwarded through proper channel.

6) Suitability of the candidate will be ascertained through interview/APARs/ credibility. Date of interview will be informed in due course.

- 7) Vigilance is an ex-cadre organization. Therefore, staff selected for posting in the Vigilance department will continue to maintain their lien and seniority in their parent cadre/Unit/Railway. Staff selected will not have any right to absorb in North Western Railway. The normal establishment rules applicable to regular selection posts are not applicable in the selection of Vigilance Inspectors (as per Para No. 821.5 of the Indian Railway Vigilance Manual-2018).
- 8) Action may be taken in case candidate once selected withdraws his name. The posting in the Vigilance organization is on a purely temporary basis and Railway Administration has full right to repatriate the person at any time without assigning any reason, even if, he has not completed initial period of tenure or extension if any granted thereto. Headquarter of Vigilance Inspector will be at Jaipur.
