SN	Rules amended
1	<p><b><u>One new Subsidiary Rule SR.3.39.09 shall be incorporated below SR.3.39.08 as under:</u></b></p> <p><b>SR.3.39.09:</b> All Station Masters and Pointsmen who are working in the Automatic Block territories shall be imparted one day orientation course once in every six months about the rules and the written authorities forms pertaining to this system by the station in-charge or Divisional Transportation Inspector.</p> <p>In case of commissioning of new automatic signaling section or new joining from Absolute Block System to Automatic Block System, two days training by concerned sectional DTI and SSE(Signal) shall be given to them and competency certificate shall be issued. No Station Master and Pointsman shall be put on duty on such sections unless he/she possesses this certificate. Intensive counselling shall be carried out by the sectional DTI once in every two months during the first year of commissioning of new automatic section or new joining, followed by one day orientation course once in every six months thereafter.</p> <p><b>A&amp;C No.32 to G&amp;SR Book(2012) and 37 to G&amp;SR Book(2010) Date-04.11.2024</b></p>
2	<p><b><u>Existing SR. 4.25.04 shall be deleted and substituted as under:</u></b></p> <p><b>SR.4.25.04:</b> "All Train Managers who are working on Automatic Block territories shall be imparted one day orientation course once in every six months, about the rules pertaining to this system. Thereafter, they shall be examined, and if found qualified, a certificate of competency shall be issued to each Train Manager by the Divisional Transportation Inspector of the Train Manager's headquarter station. A record of all such certificates issued in token of their knowledge and proficiency in these rules shall be maintained by the Station in-charge/ Divisional Transportation Inspector concerned under intimation to Sr.Divisional Operations Manager of the Division. No Train Manager shall be put on duty on such sections unless he/she possesses this certificate.</p> <p>In case of commissioning of new automatic signaling section or new joining from Absolute Block System to Automatic Block System, two days training by concerned Station in-charge/sectional DTI of the Train Manager's headquarter station shall be given to Train Managers and competency certificate shall be issued. Thereafter, intensive counselling shall be undertaken once in every two months during the first year of commissioning of new automatic section or new joining, followed by one day orientation course once in every six months thereafter.</p> <p><b>Note:</b> During commissioning of Automatic Signalling of new section, Train Managers will receive training for an initial period of two days. No additional training related to Automatic Signalling will be provided for subsequent openings of the new section.</p> <p><b>A&amp;C No.32 to G&amp;SR Book(2012) and 37 to G&amp;SR Book(2010) Date-04.11.2024</b></p>

3	<p><b>Existing SR. 3.78.02 shall be deleted and substituted as under:</b></p> <p><b>SR 3.78.02. - All Loco Pilots/Motorman/Asst. Loco Pilots who are working on sections having Automatic Block System of working shall be imparted one day's intensive counselling about the rules pertaining to this system once in every six months by Chief Loco Inspector at Crew Lobby followed by computer based multiple choice question test at Crew lobby/Electrical Training Centre/DRM office, before issuance/renewal of competency certificate. No Loco Pilot/Asstt. Loco Pilot/Motorman shall be put on duty on such section unless he/she possesses this certificate.</b></p> <p>Whenever intimation of introduction of new automatic signaling section is received, two days training of all Loco Pilots/Asst.Loco Pilots shall be started at lobby/Electrical Training Centre/DRM office by Chief Loco Inspectors and competency certificate to work in automatic section shall be issued. After commissioning of new automatic signaling section, intensive counseling of all LP/ALP once in every two months in the first year of commissioning of new section should be ensured. After that, periodical counseling once in every six months shall be introduced.</p> <p>Chief Loco Inspectors who are to issue/renew competency certificate shall undergo training on automatic signaling at ZRTIs for 3 days in every three years.</p> <p><b>Note:</b> During commissioning of new Automatic Signalling section, Loco Pilots/Asst.Loco Pilots will receive training for an initial period of two days. No additional training related to Automatic Signalling will be provided for subsequent openings of the new Automatic signaling section.</p> <p>A&amp;C No.32 to G&amp;SR Book(2012) and 37 to G&amp;SR Book(2010) <span style="float: right;">Date-04.11.2024</span></p>
