As instructed by Railway Board vide the letter dated 17.03.2025, the Party should ensure compliance of Chapter III, Para 12A.5 of GPWIS policy issued vide FM Circular No. 26/2019 dated 18.11.2019, "Nonetheless, for the rakes procured by 'producers or consumers of the goods (end-users)', it must be ensured that the consignment in at least one leg of the circuit shall be of the end-user only i.e. the consignor/consignee should be the end-user."
6. All other terms and conditions of the notification(s) issued for these rakes of the Party inducted under GPWIS will remain unchanged.
