## Commercial Circular No.90(G)/2025

**Sub:** Notification of additional O-D pairs (loading / unloading points) for 01 rake of BTAP wagons of M/s Utkal Alumina International Limited under Liberalized Special Freight Train Operator (LSFTO) Scheme.
