Sub:- Regarding recovery of OHE Maintenance Charges for Private siding in FM Circular no. 11 of 2016

Ref:- (i) Freight Marketing Circular no. 11 of 2016 issued vide Board's letter 99/TC(FM)/26/1/Pt II dated 22.08.2016

(ii) Freight Marketing Circular no. 06 of 2020 issued vide Board's letter no. 2018/TC(FM)/14/04 dated 23.06.2020.

(ii) Western Railway letters no. C491/1 (41980) dated 20.08.2024

The Board had issued revised guidelines under paragraph 9.3.1 of FMC No. 11 of 2016 regarding the "Recovery of OHE Maintenance Charges for Private Sidings" through an amendment issued under FMC No. 06 of 2020, as referenced in point (ii) above.

- 2. Zonal Railways have sought clarification on whether these revised guidelines apply to sidings that were commissioned or approved under policy guidelines issued before the FMC No. 11 of 2016 (Private Siding Policy 2016).
- 3. After due examination, it is clarified that FMC No. 06 of 2020, dated 23.06.2020, was issued as an amendment to the Private Siding Policy 2016 (FMC No. 11 of 2016). Therefore, the revised guidelines shall not be applied retrospectively to sidings or terminals where agreements were executed or governed under previous siding policies, i.e., those in effect before the issuance of FMC No. 11 of 2016.

Necessary action may kindly be taken accordingly.
