In modification to letter dated 20.02.2024, it has been decided by Board to delegate the following powers to CWMs of workshops for sanction of works under lumpsum:

SN	Planhead	Extent of powers for sanction of itemized works under Lump sum
1	PH-42	Upto Rs 4 cr.
2	PH-31	Upto Rs 1 cr. only for Workshop Yard
3	PH-36	Upto Rs 1.5 cr.
4	PH-51	i) Upto Rs 1.5 cr. ii) For works in respect of existing schools, hospitals, dispensaries, institutes, club, rest houses and infrastructure for sports: upto Rs 1 cr.

2. The exercise of the powers delegated shall be subject to existing Codal Provisions, Rules and Regulations issued from time to time by Railway Board on specific subjects.


