In partial modification to Board's letter under reference (i) above, it has been decided by Board to enhance the powers of General Managers of Production Units to sanction expenditure upto Rs.40 lakh in a year on training courses, seminars, symposia. Accordingly, Para No. A(IV)(3) of Schedule of Powers have been amended to read as under:

Para No. A(IV) (3):

"the sanction of expenditure on deputation of Railway employees for training courses, seminars, symposia in recognized non-Railway institutions in excess of Rs.1.00 crore in a year for Zonal Railways and Rs.40 lakh in a year for Production Units as detailed in Railways Board's Letter No.2018/Trans.Cell/E/Process Reforms dated 12.12.2018 as revised from, time to time."
