Sub: Delegation of Powers for tenders in construction organization.

Ref: Board's letters No. 2022/F(X)II/PW/1 dated 11.07.2024, 18.10.2024 & 22/10/2024.

Vide letters under reference, the powers for acceptance of tenders have been delegated to the Construction Organization of Zonal Railways. In continuation, it has been decided by Board (MI, MF and CRB & CEO) to delegate the following powers to the HAG officers of Construction Organization in respect of tenders:

(a) Tenders of value more than Rs. 100 Cr & upto Rs. 500 Cr (SAG level committee):

(i) **Acceptance:** by HAG level officer of the Convening Department.

(ii) **Tender Committee:** All TC members in SAG.

(iii) In case HAG level officer of the convening department is unavailable, then acceptance will be done by CAO/C in HAG.

(iv) If SAG level officer is unavailable, JAG level officer of the concerned Department will participate in the Tender Committee. Acceptance in this case will be by the HAG level of the Convening Department. In case HAG level officer of the Convening Department is unavailable, the acceptance will be by CAO/C in HAG.

(b) Tenders of value more than Rs. 500 Cr (HAG level committee):

(i) **Acceptance:** by CAO/C in HAG.

(ii) **Tender Committee:** All TC members in HAG.

(iii) If HAG Level Officer is unavailable in the Department, then the SAG level officer of the Department will be part of the Tender Committee. Acceptance will be by CAO/C in HAG.

iv) In exceptional circumstances, the GM with concurrence of PFA can consider lowering the slab of Rs.500 crores of HAG level tender committee.


