Sub:- Selection for the post of Chief Vigilance Inspector (Traffic) in Pay Matrix Level-07 of 7th PC in the Vigilance Department of East Coast Railway, Bhubaneswar.

1. In order to fill up 01 (One) Ex-cadre post of Chief Vigilance Inspector (Traffic) in pay Matrix Level-7 of 7th PC in Vigilance Department of East Coast Railway, Bhubaneswar on deputation basis, it has been decided to hold a selection for forming a panel. The panel will be valid for one year from the date of publication of the panel or till it exhausts, whichever is earlier. The selection consists of a written test and a Vigilance Aptitude & Computer Knowledge Test. The candidates who obtain at least 60% marks in the written examination will be called for appearing in the Vigilance Aptitude & Computer knowledge test.

Eligibilty Conditions:

(a) The staff should be a Graduate (as per Service Record).

(b) Computer efficiency is a desirable qualification.

(c) Staff working in Commercial / Operating department or staff having lien in Commercial/Operating Deptt. in Level-7 or one Grade below i.e, in Level-6 on a regular basis (Not under MACP)

(d) Staff upgraded in Level-8/9 in terms of RBE No. 155/2022 (as amended from time

to time) are also elgible.

- (e) The staff should have completed at least five years service in pay Level-6 or its higher Pay Level of 7th PC as on the date of notification.
- (f) Staff who has already completed their tenure in the Vigilance Organization earlier as Vigilance Inspector either in Vigilance Branch of Zonal Railway or Vigilance Directorate of Railway Board are eligible subject to after transfer from vigilance unit, a compulsory cooling off period of Three years should be observed,

(g) Ministerail staff are not eligible.

- (h) Candidate should preferably be less than 50 years of age. However, those above 50 years with atleast 05 years service left (As on the Date of the notification) can be considered if found suitable.
- (i) The staff should not have doubtful integrity, should not be figuring in any current vigilance/ SPE/DAR case and should not have been imposed with any major/ minor penalty in any past vigilance case.
- 3. Eligible candidates to forward their applications through controlling officer in the enclosed proforma only.

4. Other conditions:

(a) The normal establishment rules applicable to regular selection post need not be applied in the case of selection of Vigilance Inspector (Para 821.5 of Indian Railway Vigilance Manual, 2018, as ammeded from time to time). The applicant should have a flair for vigilance work. Adequate knowledge of DAR proceedings, along with satisfactory professional knowledge is essential.

- (c) Written Examination will be conducted only if more than 5 eligible candidates applied. If 5 or less Candidates applied (eligible), Selection will be done based on APARs for the last 3 years, Acadamic Qualification and Vigilance Aptitude & Computer Knowledge Test.
- (d) The syllabus for written test will include questions on knowledge about railway working, writing of report, Railway Establishment Rules, Departmental (Traffic) rules and regulations, Railway Codes and manuals, General awareness etc.
- (e) The post of Chief Vigilance Inspector (Traffic) is an Ex Cadre post and its tenure will normally be 03 Years (Three Years). However, an inspector can be repatriated on or before completion of the tenure without assigning any reason whatsoever. The tenure may also be extended as per extant rules.
- (f) Applications in the prescribed proforma must reach this office in a bunch and not in a piecemeal manner on or <u>before- 22.04.2025</u>. The notification may be given wide publicity amongst the staff.
