

Please refer to Rates Circular No.22 of 2017 regarding Haulage Charge for running of Double Stack Dwarf Container. These guidelines are valid upto 31.03.2025 as per Corrigendum No.5 dt.04.03.2024.

The matter has been reviewed and it has been decided to extend the currency of extant instructions regarding Haulage Charge for running of Double Stack Dwarf Container, beyond 31.03.2025, for a further period of one year i.e. upto **31.03.2026**.

This issues in consultation with Traffic Transportation directorate and with the concurrence of Finance directorate of Railway Board.




