Sub: De-notification of Parjang (PRJG) and Kamakhya Nagar (KKNR) stations as Goods shed of Indian Railways and notification of the same as Goods sheds owned by M/s Angul Sukinda Railway Limited (SPV) for handling of existing outward & inward traffic.

2. Railway Board's letter No.2006/Infra/12/4 dated 25.02.2025.

1. Vide this office circular under reference, Parjang (Alpha Code – PRJG, Numerical Code – 12121085) and Kamakhya Nagar (Alpha Code – KKNR, Numerical Code – 12121087) of Khurda Roda Division over East Coast Railway were notified as full rake handling points for handling of following outward and inward traffic.

3. All terms and conditions of the Concession Agreement and O & M Agreement with ASRL will be applicable.
4. Necessary environment norms as per State Pollution Control Board (SPCB) Consent Order at PRJG and KKNR should be fulfilled during loading / unloading operation of consignments.
