

**Sub:-** Selection for the one 'ex-cadre' post of Chief Vigilance Inspector/Medical in Pay Matrix Level-7 of (7<sup>th</sup> PC) in the Vigilance Dept, North Central Railway, H.Q. Office, Prayagraj.

Applications/options are hereby invited from the staff working under your control, on the prescribed proforma attached, which should be sent duly forwarded by the controlling officer for filling up the one 'ex-cadre' post of **Chief Vigilance Inspector/Medical** in the Vigilance Dept, North Central Railway, H.Q. Office, Prayagraj.

The normal period of tenure of the post is 3 (Three) years, which could be extended for further period upto 2(Two) years, if so required by the department. On completion of the tenure, the staff would be repatriated to the respective parent cadre on the Railway where he/she holds lien. However, the staff selected for the post could be repatriated at any time, on or before completion of the tenure without assigning any reason whatsoever.

The post is as under:-

**Eligibility Criteria:**

- 1) **Chief Vigilance Inspector/Medical:-** Staff working in the *technical cadres* of Medical department in Railway – in Pay Matrix Level-7 of 7<sup>th</sup> PC or one scale below in Pay Matrix Level-6 of (7<sup>th</sup> PC) on a regular basis.
- 2) Candidate should have completed at least five (05) years of continuous service, as on the last date for receipt of applications.
- 3) The minimum educational qualification required is five years Apprenticeship from Railway/Diploma/Graduate in any discipline.
- 4) Candidate must have sound integrity, and should not be figuring in any current Vigilance/SPE/DAR case. NO penalty (Major or Minor) should have been imposed in any past vigilance case.
- 5) Staff who have already completed their tenure in Vigilance Organization of Zonal Railways/Production Unit/Railway Board as Investigating Inspector (Vig.)/Vigilance Inspector/Ch.OS/OS/Vigilance are not eligible to apply. However, if they have completed sufficient cooling off period (minimum 2 years), thereafter, they are also eligible to apply.

**Procedure for Submission of Application:**

- 6) Application should be made in the prescribed pro-forma, and should be forwarded through the proper channel. Applications not received through 'the proper channel' will be summarily rejected. No direct applications will be entertained.

Application, as per enclosed pro-forma, must be filled and signed by the candidate himself/herself, giving the correct information to the best of his/her knowledge. No alterations/corrections on the application will be entertained. Applicants must note that if any information furnished by him/her is found to be false at any stage, the application/candidature will be liable to be rejected. Submission of false or misleading information by applicant may lead to D&AR action.

- 8) The applications/options should reach the Office of the General Manager/Vigilance, North Central Railway, Prayagraj, latest by **19.05.2025**, duly forwarded through proper channel, along with attested photograph. Eligible candidates should be ready to be called for selection within fifteen days from the closing date of the receipt of applications. This Notification is also available on Zonal Railway website **ncr.indianrailways.gov.in** → **About** → **Department** → **Vigilance** → **Selection notification** from where it can be downloaded readily.

- 9) A written test, Vigilance Aptitude and computer knowledge Test will be conducted as part of selection procedure. The distribution of marks for selection is stated below:


Candidates who obtain at least 60% marks in the written examination will be called for appearing in the Vigilance Aptitude & Computer Knowledge Test. Candidates who secure 60% of marks including record of service in aggregate will be eligible for empanelment.

Other Conditions:

- 10) The normal establishment rules applicable to regular selection posts are not applicable in the selection of Vigilance Inspectors [as per para 821.5 of the 'Indian Railway Vigilance Manual']. Mode of Selection will rest with the vigilance organization. Weightages will be given to Service Record, ACRs, length of experience, integrity, knowledge of D&AR proceedings and computers, etc.
- 11) Adequate knowledge of D&AR proceedings and computer proficiency is desirable. Preference will be given to candidates having working knowledge of computers.
- 12) Extant instructions of Railway Board regarding 02 year service for promotion shall be applicable for candidates who are in Level-6.
- 13) The vigilance work is mainly out-door, involving excessive travelling. Candidate should have interest and physical fitness for the same.
- 14) Applicants, once selected, will not be allowed to withdraw their names.
- 15) It may be noted that it will be compulsory to release the employee after selection.
- 16) The posting in the Vigilance organization is on a purely temporary basis and that the Railway administration has a right to repatriate the person at any time and without assigning any reason, even if he has not completed initial period of tenure or extension, if any, granted thereto.
- 17) Vigilance is an ex-cadre organization. Therefore, staff selected for posting in the Vigilance department will continue to maintain their lien and seniority in their parent cadre.

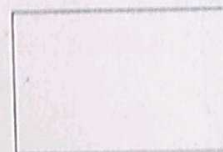
