<u>Sub</u>: Notification of additional O-D pairs (loading/unloading points) for 22 rakes of BFNV wagons of M/s Jindal Steel & Power Limited under Liberalized Special Freight Train Operator (LSFTO) Scheme.

- Vide Commercial Circulars under reference-(ii), 17 rakes of BFNV wagons (out of 22 BFNV rakes) of M/s Jindal Steel & Power Limited have been notified under Liberalized Special Freight Train Operator (LSFTO) Scheme for various close circuits (loading/unloading points) and commodities as stipulated therein.
- 2) Now, with the approval of Railway Board vide letter under reference-(iii), (copy enclosed) following pairs of loading/unloading points are hereby included as additional O-D pairs for the subject 22 rakes of BFNV wagons for transportation of Iron & Steel/Rails under LSFTO Scheme. Commodities not covered under LSFTO between the said O-D pairs may be permitted as per the extant provision of LSFTO policy (i.e. with full freight):

Note: All steel commodities carried on IR steel rakes are also feasible for the above rakes. Commodities not covered under LSFTO between the said O-D pairs may be permitted as per the extant provision of LSFTO policy.
