1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
3. Eastern Railway has forwarded proposal with due approval of General Manager to include routes in the list of already identified CC+8 routes as below:

**Bandel Jn.(BDC) - Katwa (KWAE) (DN Line)**

4. Matter has been examined and sanction of the Competent Authority is hereby accorded to include the above referred route of Eastern Railway in the list of already identified CC+8 routes subject to prescribed permissible speed. This speed limit can be reviewed by the Zonal Railway and may be revised as and when required.
5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
7. These instructions shall come into effect from 03.05.2025 and shall remain valid till further advice.
8. This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
