Sub:- LSFTO Rakes damage by third party loading

Board is in receipt of concerns from the LSFTO rake owners where the rakes are being damaged by the third party during loading.

2. In this regard, it is reiterated that Paragraph 12.5 of the LSFTO policy states:

"The rakes may be used by IR in an emergency for traffic offered by customers other than the SFTO, subject to a prior mutual written agreement between IR and such SFTO."In view of the foregoing, zonal railways are directed to ensure the provisions of the LSFTO policy.

3. On placement of the rake for third party (non-rake owner) if there is some visible damage, such party shall inform the Goods clerk on duty, who shall communicate the same to the rake owner. However, if no damage is reported by the party at the time of placement, the Goods clerk on completion of loading/unloading shall physically inspect the rake from both sides. If any visible damage is found, he shall book this damage to the party who has carried out such loading/unloading. Rake shall not be detained.

On the basis of report submitted in the above scenarios, detailed inspection for ascertaining the damages shall be conducted jointly by the responsible party and the owner of the wagon as soon as possible and such damages shall be recoverable by the owner from the responsible party as mutually agreed.

4. This issues with the approval of competent authority.
