Sub: Physical induction of 17 spare wagons & 02 Brake Vans and conversion of 23 BOXNHL wagons inducted by M/s T M International Logistics Limited under GPWIS into BOXNHL25T wagons.

- 1) The 29th, 30th, 31st, 32nd, 33rd, 34th, 35th, 38th & 39th BOXNHL rakes of M/s T M International Logistics Limited were initially notified under GPWIS vide PCCM/ECOR's Commercial circular as mentioned below:

- 2) The spare wagons notified with the 29th, 30th, 31st, 32nd, 33rd, 38th & 39th rakes of the Party and 01 Brake Van each with 29th & 31st rakes were not physically inducted with these rakes. Now, these wagons & Brake Vans have been commissioned at their base depot and hence have been physically inducted.
- 3) Further, Railway Board vide letter No.2018/TC(FM)/4/06 dtd.12.03.2021 have issued instructions that BOXNHL wagons procured under GPWIS would be converted into BOXNHL25T wagons.
- 4) Accordingly, some BOXNHL wagons of the above mentioned rakes have been converted into BOXNHL25T wagons at maintenance depot at Bondamunda (BNDM) & Bokaro (BKEY) of South Eastern Railway.
- 5) GPWIS module of TMS/FOIS has been modified accordingly with respect to the wagon type, PCC etc. of these wagons in individual Agreement ID.
- 6) The list of the modified wagons is enclosed as Annexure-1.

All other terms and conditions of the commercial circulars under reference will remain unchanged.

All concerned to note and act accordingly.
