



1. In terms of Rates Circular under reference and corrigenda thereto, guidelines were issued on the subject policy which is operative upto 31.03.2026.
2. The matter has been reviewed. Sanction of the Competent Authority is hereby accorded for addition of certain traditional empty flow streams originating from Western Railway for Flat & Mixed steel rakes (enclosed in Annexure).
3. All other details of the policy will remain unchanged.

5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate in the Ministry of Railways.


