Sub: Conversion of 65 BOXNHL wagons inducted by M/s Adani Logistics Limited under GPWIS into BOXNHL25T wagons.

- 1) The 18th, 19th, 20th, 21st, 22nd, 23rd, 25th, 26th, 29th & 32nd BOXNHL rakes of M/s Adani Logistics Limited were initially notified under GPWIS vide the Commercial circulars mentioned in the table below:

- 2) Railway Board vide letter No.2018/TC(FM)/4/06 dtd.12.03.2021 have issued instructions that the BOXNHL wagons procured under GPWIS would be converted into BOXNHL 25T wagons.
3) Accordingly, some BOXNHL wagons of the above mentioned rakes have been converted into BOXNHL25T wagons at their maintenance depot at Nimpura (NMP/NPRY) of South Eastern Railway.
4) GPWIS module of TMS/FOIS has been modified accordingly with respect to the wagon type, PCC etc. of these wagons in individual Agreement ID.
5) The list of the modified wagons is enclosed as Annexure-1.

All other terms and conditions of the commercial circulars issued for these rakes will remain unchanged.

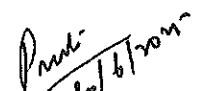

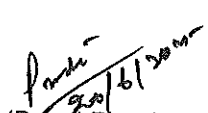
