**Sub:Restriction of Inward parcel traffic over Kamakhya Station during  
Ambabuchi Mela w.e.f. 22.06.2025 to 26.06.2025.**

Extract of the CCM(FM)/NFR's letter No. C/163/RD-5/Parcel/Restriction dated 20.06.2025 is reproduced below for information and necessary action please:-

“ Keeping in view the security arrangements during Ambabuchi Mela that is expected to attract heavy passenger rush, restriction is hereby imposed on all inward parcel handling activities (including handling of leased SLRs, VPs & demand VPs) at Kamakhya (KYQ) station from 22.06.2025 to 26.06.2025 to keep parcel godown and platforms free of parcel packages/packing to facilitate free movement of passengers.

For outward loading, division should take all precautions to streamline the loading in a disciplined manner directly from parcel shed to SLRs/VPs for ensuring obstruction free passenger movement.

The personal luggage may be allowed in the passenger coach only and booking of registered newspaper, magazines shall be permitted after observing all commercial formalities”.

All concerned to please note and act accordingly.
