APARs for the years 2019-20, 2020-21, 2021-22, 2022-23 & 2023-24, original Service Book, D&A clearances (duly countersigned by a Gazetted Officer) and original medical fitness certificates of prescribed standard for the post of AME/Group-B of the above named candidates, for the viva-voce test, should be sent to Dy.CPO(HQ)/ECoR/BBS latest by 22.07.2025 positively.

In terms of Railway Board's letter No. E(GP)80/2/8 dtd. 31.10.91 only those candidates who qualify in the medical examination of prescribed standard should be advised to appear in the viva-voce test. <u>Accordingly, the respective controlling officers/Personnel Officers should direct the above named candidates for medical fitness of prescribed standard for the post of AME/Group-B before the viva-voce test.</u>

The candidature of the candidates appearing in the viva-voce test has been accepted provisionally. If any candidate is subsequently found ineligible at any stage of the selection, his name will be deleted without further notice.
