Sub: Transport Allowance to NF-HAG (Pay Level-15) officers of Medical Department.
 Ref : Representation dated 20.06.2025, submitted by Dr. Sanjib Kumar Sahoo, ACMS/ DRH/
 SBP, addressed to PCPO for higher rate of Transport Allowance through e-office file
 No. 85328 dated 26.03.2025.

The claim of the above named IRMS officer/SBP for higher rate of Transport Allowance has been examined in terms of RBE No. 68/2014, RBE No. 81/2017, RBE No. 138/2019 and RB's letter No. 2009/H/16/IDACP dated 26.02.2009 and found that only officers holding functional SAG posts are entitled to higher rate of Transport Allowance or official car facility. Officers promoted under DACP/NF-upgradation are not eligible. Dr. Sanjib Kumar Sahoo, who was appointed to officiate in SA Grade (Level-14) under DACP w.e.f. 01.04.2017, vide this office Memorandum dated 30.11.2018 and granted NF-HAG (Level-15) w.e.f. 06.08.2024, vide this office Memorandum dated 23.10.2024 is not holding any pin pointed administrative post at Sambalpur as mentioned at Srl No. 6 in RB's letter No. 2009/H/16/IDACP dated 26.02.2009. Therefore, he is not eligible to opt for higher rate of Transport Allowance @ Rs 7000/- p.m.+DA thereon (which now stands revised to Rs 15750/- p.m.+DA thereon based on the recommendations of the 7th CPC). The officer concerned is entitled for Transport Allowance @ Rs 3600/- p.m + DA thereon at Sambalpur as per row-2 of Board's letter No. PC-V/2017/A/TA/1 dated 03.08.2017 (RBE No. 81/2017). The reply from DRM(P)/SBP vide his letter No. DRM(P)/SBP/Gaz/TRA/Claim/ACMS-SKS dated 13.06.2025, is found in conformity with the extant rules.

As decided by the competent authority the excess payment made should be recovered from Dr. Sanjib Kumar Sahoo and other similarly placed IRMS officers (Doctors) posted over ECoR, who have not been found eligible for Transport Allowance at the higher rate as per RBE No. 54/2021.

The aforesaid representation dtd 20.06.2025 is hereby disposed off.
