Ref: Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 and its amendments

One of the Zonal Railways has requested to prescribe separate free time for BCNHL rakes in case of EOL terminals.

Para 2.5 of Chapter-I of Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 prescribes guidelines regarding free time for loading/unloading in case of EOL terminals.

The matter has been reviewed and it has been decided to prescribe separate free time for BCNHL rakes in case of EOL terminals, as under:

Type of rake	EOL free time (hours : minutes)	
	Loading	Unloading
BCNHL Rake	08:00	08:00
Covered Rake (other than BCNHL)	06:00	06:00

Accordingly, Para 2.5 of Rates Master Circular/Demurrage-Wharfage-Waiver stands modified.

These guidelines will be implemented w.e.f. 17.07.2025.
