- 1) In terms of Railway Board's letter under reference, it has been decided for re-engagement of the retired staff in Pharmacist category in Medical department at Titlagarh Health Unit of SBP Division.
- 2) Number of vacancies: 01(One) in Pharmacist Entry Grade (Pay Level-5) at Titlagarh Health Unit of SBP Division.

# 3) Eligibility Condition:-

- a) Pharmacists retired in Pay Level-5 and staff who retired from posts in the same cadre / category up to three levels higher than the post against which re-engagement is being considered, will be considered for re-engagement.
- b) Excludes those under SRRS/LARSGESS or with DAR/Vigilance cases.
- c) Must have "Good" grading in the last five years APARs.
- d) Applicants should not be above 65 years of age as on the date of notification.

The remuneration and allowances for re-engaged retired staff will be as per OM OM No. F.No.3-25/2020-E.IIIA dated 09.12.2020 issued by the Department of Expenditure, Ministry of Finance, Government of India which are as under:

- a) A fixed monthly remuneration will be calculated by deducting the basic pension from the pay drawn at the time of retirement. This amount will remain unchanged during the contract period.
- b) No increment, Dearness Allowance (DA) or House Rent Allowance (HRA) will be allowed during the contract period.
- c) A fixed Transport Allowance for commuting between residence and the workplace will be allowed, not exceeding the rate applicable at the time of retirement. This amount will remain unchanged during the contract period. However, TA/DA for official tours will be allowed as per entitlement at retirement.
- d) Paid leave will be granted at the rate of 1.5 days per completed month of service. Accumulation of leave beyond a calendar year is not allowed.

## 5) Mode of Selection:-

Suitability/Competency of the staff should be adjudged by a committee at an appropriate level before such re-engagement duly taking into account safety and other operational requirements.

### 6) Duration of Re-engagement Scheme:-

- a) The scheme will remain in effect for an initial period of 02 years from the date of issue of instructions or until further orders, whichever is earlier.
- b) The engagement period for an individual retired staff will be 01 year or until further orders or regular incumbent is made available through RRB, whichever is earlier.
- c) Based on satisfactory performance, the engagement may be extended for an additional year or until the retiree attains 65 years of age, whichever is earlier.
- d) Re-engaged staff should be discharged immediately on joining of selected candidates from RRBs.

#### 7) Other Terms and Conditions:-

All other terms and conditions for re-engagement will be governed by Rly. Bd. Letter No. E(NG)II/2024/RC-4/9 Dated 15.10.2024 (RBE No. 96/2024, RBE No. 115/2024, RBE No.55/2025 & RBE No. 61/2025) and any other orders issued by the Railway from time to time.

8) Documents to be required:-

Retired employees are advised to bring the following documents for verification at the time of Suitability test / Competency test / Viva-voce Test.

a) Application in prescribed format.

- b) Service Certificate.
- c) Pensioner Identity Card.
- d) Pension Payment Order.
- e) Three passport size photographs.

9) How To Apply:-

Eligible and interested retired employees are advised to send their applications in prescribed format along with self attested Photostats copies of the relevant documents on or before 27.08.2025 preferably to the E-mail Account: reengagement.sbp@gmail.com

OR

Retired staff can submit their application directly in the drop box in front of Room No.-06, Staff Section (First Floor) at Divisional Engineering Training School, East Coast Railway, Sambalpur or through Speed Post / Registered Post addressed to Divisional Personnel Officer, East Coast Railway, Post-Modipara, Dist-Sambalpur-768002, Odisha superscribing on the top of the envelope "Application form for re-engagement of retired employee for Pharmacist" on or before 27.08.2025. The date of viva-voce test will be intimated over telephone or letter for attending the viva-voce test accordingly.

Application received after due closing date / time for any reason will not be considered.

10) Retired employees are hereby requested to read the terms and conditions in detail as outlined above and in RBE No. 96/2024, RBE No. 115/2024, RBE No.55/2025, RBE No.61/2025. Submission of an application will be treated as acceptance of all the terms and conditions specified in this notification.

11) No TA/DA/Accommodation will be provided to the retired railway employees for attending the vivavoce test.
