In continuation to PCPO/BBS notification No. ECoR/Pers/04/Engg./ HQ/Re-Eng./Retd./ State-Gov. Revenue/Forest Official/25 Dt.23.01.2025, it has been decided by East Coast Railway for reengagement of retired State Government officials from Forest /Revenue Departments on contract basis for work related to Survey, updation of land records, coordination with State Government agencies for forest/wild life clearances in railway projects where land acquisition is involved in important railway infrastructure projects over East Coast Railway under Chief Administrative Officer/Con/ECoR.

1.Period of contractual engagement: The period of contractual engagement is up to 21.02.2026.

2.Vacancy: 02 nos. For filling up of 02 (Two) posts of Consultant Forest Range Officer/ Forest Ranger for the Railway Project on re-engagement basis, applications are invited from following designated retired State Govt. Officials.

- 15. How to apply:-The details of name of the posts, vacancies, eligibility conditions are enclosed as Annexure-I. Eligible and interested retired state govt. officers may apply as per the application format in Annexure-II. The duly filled in application should be sent to office of The Principal Chief Personnel Officer, East Coast Railway, 2nd Floor, South Block, Rail Sadan, Chandrasekharpur, Bhubaneswar, Odisha-751017 in an envelope so that the applications with required documents should be reached on or before 03.09.2025. The envelope should be superscribed with "Application for the Post of Consultant Forest Ranger/ Forest Range officer.
- 16. Mode of selection: The candidates will be screened by a Selection Committee and their suitability will be adjudged keeping in view the job requirements/service particulars/relevant work experience etc.
- **17. Medical Fitness:** While re-engaging such staff, medical fitness of the appropriate category should be obtained from the designated authorities as per existing practices.
- 18. Age Limit: Maximum age limit for such re-engagement shall be 65 years.

19. TERMS AND CONDITIONS:

- (i) A fixed monthly amount shall be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of contract.
 - (ii) No increment, Dearness Allowance and HRA shall be allowed during the term of contract.
 - (iii) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate of applicable to the appointee at the time of retirement.
 - iv) The amount so fixed shall remain unchanged during the term of appointment. However, they may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
 - v) Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of service.
 - vi) Suitability/competency of the staff shall be adjudged before such re-engagement.
 - vii) Maximum age limit for such re-engagement shall be 65 years.
 - viii) The integrity aspect will be checked while permitting such re-engagement.
 - ix) No such re-engaged staff will continue in service beyond 65 years of age in terms of extant rules.
 - (x) The employees who were removed/dismissed or compulsory retired as a result of Disciplinary action are not eligible for re-engagement.
 - (xi) The re-engaged officials will not be eligible for any kind of leave (like CL, RH, LAP, sick leave etc).
 - (xii) The re-engaged retired official shall sign an agreement of confidentially with the Railway containing a clause on Ethics and Integrity.
 - (xiii) The re-engagement can be terminated without any notice and without any explanation or any reason.
 - (xiv) The Administration reserves the right to deploy the candidates in any area depending upon the exigency of the service and refusal or otherwise will be deemed as misconduct on the part of the candidates.
 - (xv) The Railway Administration reserves the right to cancel, amend or otherwise modify all or any of the terms of the notification without assigning any reason thereof.
 - (xvi) Officers engaged on contract basis can not claim to employment privileges or facilities as applicable to Railway employees.
 - (xvii) General conditions of contract for services 2018 and its amendments are applicable for this contract.
