Sub: Selection for promotion from erstwhile Group "D" to Group "C" and within Group "C" staff through Suitability Test, PQ, LDCE, GDCE, Etc.- Publication of answer keys for the objective type multiple choice questions papers regarding.
 Ref: GM(Vig)/BBS's confidential letter No. ECoR/VI/P/Compl/107/24/2018 dated 22.07.2025.

GM(Vig)/BBS has raised objection that the system of objection tracker introduced by Railway Board vide Letter No. E(NG)/I/2018/PM1/4 dated 03.08.2022 (RBE No. 91/2022), regarding above mentioned subject is not scrupulously followed over ECoR. In an Vigilance investigation of departmental selection case, it is noticed that after completion of the written examination, answer keys along with list of the candidates appeared in the written examination were not published in the Railnet. Therefore, a number of applications were received under RTI Act-2005. Many staff even knocked doors of Hon'ble CIC & Hon'ble Courts for justice which put the administration in an embarrassing situation, which could have been easily avoided had the laid down procedure been followed at the right stage of the Selection.

In view of the above, it has been decided that in order to avoid adverse remarks from the Hon'ble CIC & Hon'ble Court of Laws, avoidable RTI queries, in the interest of transparency and accuracy in departmental Selections where the component of written examination is involved, the system of 'objection tracker' introduced vide Board's Letter No. E(NG)/I/2018/PM1/4 dated 03.08.2022 (RBE No. 91/2022) and instructions issued therein regarding objections on Questions, Answer keys received through representations within the stipulated time with evidence, decisions taken thereon, publication of final Answer keys in Railnet and process of evaluation etc. are hereby reiterated for strict adherence.
