
1.0 Policy guidelines were issued from time to time in terms of Board's letter under reference for levy of Busy Season Charge (BSC) on goods traffic.

2.0 The matter has been reviewed. It has been decided by the Competent Authority to grant exemption from levy of Busy Season Charge on all Bamboo traffic in Covered wagons originating from North East Frontier Railways.

3.0 All other terms and conditions shall remain the same.

4.0 These instructions shall come into force with effect from 01.08.2025 till 31.03.2026.

5.0 This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.




